## **Early Years Foundation Stage Policy**

The Early Years Foundation Stage is a framework for children from birth to five years old, setting out seven areas of learning and development. At Lons Infant School children join Reception in the year that they turn five.

Our carefully planned curriculum, quality interactions and use of assessment ensures that we address the seven key features of effective practice as outline by the Statutory Framework for EYFS (January 2024):

- The best for every child
- High quality care
- The curriculum
- Pedagogy
- Assessment
- Self regulation and executive function
- Partnership with parents

The EYFS is based upon four principles:

- A Unique Child
- Positive Relationships
- Enabling Environments
- Learning and Development

### **Areas of Learning:**

There are three prime areas of learning which underpin children's learning in all other areas. These are:

- Communication and Language;
- Physical Development;
- Personal, Social and Emotional Development.

The four specific areas of learning are:

- Literacy
- Mathematics

- Understanding the World
- Expressive Arts and Design

None of these areas can be delivered in isolation from the others. They are equally important and depend on each other. All areas are delivered through a balance of adult led, adult supported and child initiated activities.

**Inclusion:**

In our school we believe that all children matter. We give our children every opportunity to achieve their best. We do this by taking account of our children’s range of life experiences when planning for their learning.

In the EYFS we set realistic and challenging expectations which meet the individual needs of our children. We achieve this by planning to meet the needs of boys and girls, children with special educational needs, children who are more able, children with disabilities, children from all social and cultural backgrounds, children of different ethnic groups and those from diverse linguistic backgrounds.

We meet the needs of all our children through:

- planning opportunities that build upon and extend children’s knowledge, experience and interests, and develop their self-esteem and confidence;
- using a wide range of teaching strategies based on children’s learning needs;
- providing a wide range of opportunities to motivate and support children and to help them to learn effectively;
- providing a safe and supportive learning environment in which the contribution of all children is valued;
- using resources which reflect diversity and are free from discrimination and stereotyping;
- planning challenging activities for children whose ability and understanding are in advance of their language and communication skills;
- monitoring children’s progress and taking action to provide support as necessary.

It is important to us that all children in the school are safe. We aim to educate children about boundaries, rules and limits and to help them understand why they exist. We provide children with choices to help them develop this important life skill. Children should be allowed to take risks but need to be taught how to recognise and avoid hazards. We aim to protect the physical and psychological well-being of all children. (See whole school Child Protection Policy)

**Welfare:**

At Lons Infant School we understand that we are legally required to comply with certain welfare requirements as stated in the Statutory Framework for Early Years Foundation Stage 2021. We understand that we are required to:

- promote the welfare of children;
- promote good health, preventing the spread of infection and taking appropriate action when children are ill;
- manage behaviour effectively in a manner appropriate for the children’s stage of development and individual needs;

- ensure all adults who look after the children or who have unsupervised access to them are suitable to do so;
- ensure that the premises (indoor and outdoor), furniture and equipment is safe and suitable for purpose;
- ensure that every child receives enjoyable and challenging learning and development experiences tailored to meet their needs;
- maintain records, policies and procedures required for safe, efficient management of the setting and to meet the needs of the children.

We endeavour to meet all these requirements.

### **Positive Relationships:**

At Lons Infant School we aim to develop caring, respectful, professional relationships with children and their families. To facilitate this we encourage parents to contact us via dojo, email or in person at the start of the day or at home time so that any queries can be dealt with as soon as possible.

### **Parent Partnerships:**

We recognise that parents are children's first educators and we value the contribution they make. We recognise the past, present and future role that parents play in educating their children.

We do this through:

- EYFS staff gathering information from nursery settings prior to starting school;
- Arranging two transition visits, one including lunch, in the term before they start school;
- Inviting all parents to an induction meeting the term before their child starts school;
- Encouraging parents to talk to the child's teacher if there are any concerns.
- Children starting school full time on the first day they are eligible to start. Staggered starts will be arranged if needed and requested by our parents.
- Offering a range of activities which support the involvement of parents in their child's learning, for example, encouraging parents to add to their child's portfolio on dojo and reading record books and organising curriculum meetings for parents to support the teaching and learning of phonics and the development of reading skills.

Formal meetings take place in the Autumn and Spring terms at which the teacher and the parent discuss the child's progress. Informal 'Stay and Play' craft and razzle dazzle reading mornings are also arranged during the year. Parents receive a report on their child's attainment and progress at the end of the Foundation Stage.

All staff involved with the EYFS aim to develop good relationships with all children, interacting positively with them, promoting good vocabulary and taking time to listen. At our school the EYFS teacher within the class acts a 'Key Person' to all children in EYFS, supported by Teaching Assistants.

### **Enabling Environments:**

At Lons Infant School we recognise that the environment plays a key role in supporting and extending children's development. Through observation we assess the children's interests, stages of development and learning needs, before planning challenging, achievable activities and experiences to extend the children's

learning. We believe that by extending children's learning through developing their own interests gives every child the opportunity to shine.

### **Observation, Assessment and Planning:**

On entry to Reception, the children take part in baseline assessments to identify their strengths and help staff identify the next steps in their learning at the start of the school year.

The planning within reception may be based around half termly themes or planned to reflect current interests or events. These plans are used by the teaching staff as a guide for weekly planning, however the teacher may alter these in response to the needs, achievements and interests of the children from, the previous weeks learning.

We make regular assessments of children's learning and we use this information to ensure that future planning reflects identified needs. Assessment in the EYFS takes the form of observations, and the class teacher and other adults in the room will make observations of children's interests, significant steps in their development and acquisition of skills. Parents are also actively encouraged to make observations and contribute towards learning journeys.

Observations are recorded using Class Dojo, where each child has an individual portfolio. These are used to inform the EYFSP (the document which summarises and describes the children's attainment at the end of the Early Years Foundation Stage). Parents are able to log in to their child's dojo account to read observations made in school and add their own observations from home. Work that children have completed in provision is added to dojo so that this can be used as additional evidence to assess children's knowledge and skills. Parents receive a mid-point review in the Spring term and an annual report in July, which offers brief comments on their child's achievements in each area of learning. In addition, the children are regularly assessed to monitor their acquisition of phonemes and tricky words as set out by the SSPP, Little Wandle.

### **The Learning Environment:**

The EYFS classroom is organised to allow children to explore and learn securely and safely. There are areas where the children can be active, be quiet or rest. The classroom is organised into learning areas, where children are able to locate equipment and resources independently. The EYFS classroom have access to their own outdoor area. This has a positive effect on the children's development. Being outdoors offers the children further opportunities to explore, use their senses, develop their language skills and be physically active. We plan activities and resources both inside and outside enabling the children to develop in all the areas of learning.

### **Learning and Development:**

At Lons Infant School we recognise that children learn and develop in different ways and have their own learning styles. We value all areas of learning and development equally and understand that they are often inter-linked. We believe that learning is underpinned by the characteristics of effective learning. Staff in EYFS reflect on the different ways that children learn and reflect these in their practice giving every child the opportunity to shine.

The 3 characteristics of effective teaching and learning are:

- **Playing and exploring** - children investigate and experience things, and 'have a go';
- **Active learning** - children concentrate and keep on trying if they encounter difficulties, and enjoy achievements; and
- **Creating and thinking critically** - children have and develop their own ideas, make links between ideas, and develop strategies for doing things.

All of these areas interlink throughout the curriculum and adults make the most of opportunities to interact with children to develop their playing, thinking and learning. Adults also recognise that there are times when they need to take a step back to enable children to think critically and solve a problem by trial and error or perseverance. At Lons Infant School we have been awarded the communication friendly award and are continuously working on how we can strengthen communication and interactions with the children.

### **Teaching and Learning Style:**

Our policy on Teaching and Learning defines the features of effective teaching and learning in our school. These features apply to teaching and learning in the EYFS just as much as they do to the teaching in Key Stage 1.

The more general features of good practice in our school which relate to the Foundation Stage are:

- the partnership between teachers and parents, so that our children feel secure at school and develop a sense of well-being and achievement;
- the understanding that teachers have of how children develop and learn, and how this affects their teaching;
- the range of approaches used that provide first-hand experiences, give clear explanations, make appropriate interventions and extend and develop play and talk or other means of communication;
- the carefully planned curriculum that helps children work towards the Early Learning Goals throughout EYFS;
- the provision for children to take part in activities that build on and extend their interests and develop their intellectual, physical, social and emotional abilities;
- the encouragement for children to communicate and talk about their learning, and to develop independence;
- the support for learning with appropriate and accessible indoor and outdoor space, facilities and equipment;
- the identification of the progress and future learning needs of children through observations;
- the good relationships between our school and the settings that our children experience prior to joining our school.

### **Monitoring and Review:**

It is the responsibility of EYFS teachers and practitioners to follow the principles stated in this policy. The governing body has the opportunity to discuss EYFS practice with the practitioners and raise any issues that require discussion. The Head teacher and subject leaders carry out monitoring of the EYFS through observation and discussion as part of the whole school monitoring schedule.
